BS EN 1176 / 1177 Playground Safety Standards – 2008 Revisions

The Play Inspection Company, in association with Wicksteed Playscapes, will be running events across the UK during 2008, focusing mainly on the forthcoming updates to the safety standards for children's playground equipment and surfacing.
