Environmental Quality – Natural Elements and Cleanliness

Diversity of Play Opportunities

Is there adequate space for running and team games?

Is there access to materials that encourage creativity, such as sand, water, or loose parts?		
Are there spaces that encourage group interaction and cooperative play?		
Are seating arrangements conducive to social engagement?		

Integration with the Curriculum

Accessibility and Inclusivity

Community Involvement
